Effective July 1, 2016, DHC updated its system of local public housing preferences. On and after July 1, 2016, DHC Public Housing applicants who are Disabled and/or Displaced by a Federally Declared Disaster occurring after July 1, 2005, will have priority on each of DHC's public housing wait lists. The Working preference is no longer a DHC Public Housing local preference as of July 1, 2016. If you are a current DHC Public Housing applicant and believe that this change will impact your Public Housing applicant status, please contact the management office for the site where you applied for Public Housing.

DHC offers professional onsite management, 24-hour emergency maintenance, a stove and refrigerator for residents, and the option to pay rent based on household income. At Riverbend and Harriet Tubman, Electricity, Gas and Water are included in the rent. At Brewster, Sojourner Truth, and Alexandrine, Water is included in the rent. Be sure to ask about move-in specials.
