3) DHC no longer accepts Low Income Public Housing applications at either its Customer Service Center (2211 Orleans, Detroit, MI, 48207) or Main Administrative Office (1301 E. Jefferson, Detroit, MI 48207). Further, DHC's Resident Selection Office has been closed. As DHC has transitioned to site-based wait lists, if you are interested in public housing, you must apply at the community of interest. Applications will be available Monday – Friday, from 10:00 a.m. to 3:00 p.m. **NOTE: Section 8 Housing Choice Voucher participants must submit a separate application if you are interested in public housing.**

The DHC is a federally funded Public Housing Agency which provides housing opportunities for low-income families. Families admitted to DHC's Low Income Public Housing Program live at one of DHC's public housing communities, which are located in Detroit, Michigan. Prior to admission, the DHC verifies the family's income and other household circumstances, including criminal and credit background checks for all adults. Families deemed both eligible and suitable for admission will be offered an opportunity to lease a unit with DHC. Families who lease DHC public housing units have the option of paying either an income-based rent (based on a family's ability to pay (usually 30% of a family's monthly adjusted income), regardless of the size of the leased unit) or a flat rent (based on the number of bedrooms of the leased unit). **At DHC's Senior Designated and General Occupancy communities, gas, electricity, and water are included in the rent.**

Priority for admission will be given to applicants who qualify for one or more of DHC's local preferences (pending verification by DHC):

- Person(s) displaced by a federally declared disaster occurring after July 1, 2005;
- Victims of Domestic Violence;
- Working Families;
- Elderly Families;
- Disabled Families.
